Routes to the match site

From south – Follow RT 17 North towards I-66. Follow RT 17 Business to Marshall. At the intersection of RT 17 and Business RT 55 (stop light) proceed straight ahead on RT 710 (Rectortown RD) Follow RT 710 for 4 miles to Rectortown. Turn right on RT 624 (Crenshaw Rd) and continue to the show grounds on the right.

From East or West on I-66 – Take 66 West to exit 28 (RT 17) to Marshall. Follow RT 17 Business to Marshall and proceed as above.

From East or West on Rt 50 – (between Middleburg and Upperville) Turn south at ATOKA and take RT 713 straight ahead 4 miles to RT 710, turn right and proceed as above.
